### USE DIRECTIONS:

It is recommended that a complete soil test be made to determine pH and nutrient level before applying TEP CalMend to the soil. Soil test data allows for the most efficient and effective application rate.

### Suggested Application Rates (lbs/acre):

- Spot Treatment: 250-1,000
- Broadcast-Specialty Crops: 250-1,000
- Side Dress/Drilled Band: 50-200
- Broadcast-Row crops and alfalfa: 100-250

**Application:** The granulation of TEP CalMend allows for uniform application and easy blending. A minimum moisture is required to activate the product. For best results, spread TEP CalMend and thoroughly wet for soil incorporation.
